They have been organising, implementing, participating, and following up Erasmus+ youth projects. We have a strong network within Turkey and the EU regarding the Erasmus+ Projects.</p> <p>To briefly mention our capacity.</p> <ul style="list-style-type: none"> - After the establishment of the association, our first project was prepared for the European Union Civil Society Programme and has been implemented. As part of the project, a Website and Organizational Identity Study was conducted. - Our second project is the "Traffic Education Park for Children." This project encompasses both infrastructure and superstructure developments. Additionally, children receive education in this field through training and awareness programs.
